## Cooled Semen Stallion Service Contract

This agreement is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_ by and between \_\_\_\_\_ (herein after referred to as the mare owner) and Triple T Paints.

1. The mare owner agrees to breed the mare (Registered Name)\_\_\_\_\_ and (Registry Number) \_\_\_\_\_ to the stallion **Mighty Awesome** (Registry number 212878) standing at **Triple T Paints** during the 200 breeding season. The breeding season shall be between February 1<sup>st</sup> to June 1<sup>st</sup> of said year.
2. The mare Owner agrees to pay a stallion service fee of \$2,250.00 of which \$250.00 deemed as the booking fee is payable with this contract and is non-refundable. The balance being due prior to the first shipment of semen.
3. The mare Owner will send a complete current copy of the mare's registration papers with this contract as well as any necessary lease information or documentation needed.
4. The mare must be in healthy and sound breeding condition. **Triple T Paints** recommends the Mare Owner use a vet that is experienced with cooled semen.
5. All shipments of semen will be subject to a collection and shipping fee of \$200.00 per shipment. All payments must be made prior to shipping.
6. The Mare Owner is responsible for the return of the equitainer to **Triple T Paints**. If the equitainer is not returned within three business days of receipt of the semen, a charge of \$200.00 will be required.
7. Semen is collected and shipped on Monday, Wednesday and Friday. The stallion will not be taken off his schedule for cooled semen.
8. **Triple T Paints** requires that the Mare Owner notify us no later than 9 p.m. the evening before the shipment of semen the following day. If your mare is going to foal or you know approximately when your mare should be cycling within a month of when you are intending to breed please alert the stallion manager so we can make note of when to expect your order.
9. **SEMEN IS SUBJECT TO AVAILABILITY**- Orders will be filled in the order in which they come in for that collection. If we are unable to send semen to your mare on a particular day, you will be at the top of the list for the next collection day. Every effort will be made to fill all orders, but we ask for your understanding when demand exceeds the supply. **Triple T Paints** will not be held liable if the mare is missed due to shortage of semen.
10. **Triple T Paints** will ship semen during the normal breeding season, if however the ,mare does not settle, the mare will be eligible for a rebreed at the ranch the following year.
11. **Triple T Paints** guarantees a live foal from this breeding. A live foal is defined as one that stands and nurses unassisted. If the mare aborts or the foal does not stand and nurse the mare is allowed a rebreed via cooled semen or at the ranch the following year. This guarantee is null and void if **Triple T Paints** is not notified within one week of the foal's demise or when the mare is found to have aborted. This notice must be accompanied by a statement from a licensed veterinarian. This guarantee is non-transferable without prior consent of **Triple T Paints**.
12. The Mare Owner must administer the necessary Rhino Pneumonitis vaccines at the fifth, seventh and ninth months of pregnancy. Failure to do so results in the nullification of the live foal guarantee.

13. **Triple T Paints** guarantees a foal resulting from this breeding that will meet current APHA regulations for the regular registry. In the event that the foal will not make the regular registry the Mare Owner will be entitled to a rebreed the following year for a chute fee of \$1,000.00 plus the semen shipping fee for the cooled semen or the mare care, vet and breeding charges at the ranch.
14. A licensed veterinarian between 18 and 30 days must examine the mare after the last bred date and **Triple T Paints** advised of her pregnancy status within ten days of her examination or all guarantees become null and void.
15. Should the stallion die or otherwise become unfit for breeding this contract shall be null and void. If the mare should die or become unfit for breeding this contract is null and void unless written approval from **Triple T Paints** granting the use of a substitute mare.
16. This contract is non-transferable in part or whole without the expressed written consent of **Triple T Paints**.
17. **Triple T Paints** will issue a breeder's certificate when notified of the birth of the foal resulting from this breeding providing that the mare owner has no outstanding debt to **Triple T Paints**. In the event of a debt the breeder's certificate will only be issued once the debt has been paid in full.
